Regular Meeting:

The Town Council of Gurley, Alabama, met on March 5, 2024, at 7:00 p.m. in the Gurley Town Hall for a regular meeting.

President Pro Tempore, Gary Boyett called the regular meeting to order. Upon roll call, present were Richard Meyers, Joseph Belles, Tammy Whitten, Robert Winn and Gary Boyett.

Reading of Minutes:
