Regular Meeting:

The Town Council of Gurley, Alabama, met on April 16, 2024, at 7:00 p.m. in the Gurley Town Hall for a regular meeting.

Mayor Simpson called the regular meeting to order. Upon roll call, present were Richard Meyers, Joseph Belles, Robert Winn and Stan Simpson.

Business License for Approval:

a. Loblollies Boutique LLC

Ms. Sneed was present and discussed her business.

A motion was made by Meyers, seconded by Winn to approve the business license for Loblollies Boutique LLC. Upon roll call: Yea's – Meyers, Belles, Winn & Simpson. Nay's – None. Having unanimous consent, motion carried.

- **Police Department:** Mayor Simpson reported the black police car is due to be fixed on Friday. The new cruiser is waiting on a box system from Sharp's.

Hearings of Petitions, Applications, Complaints, Appeals, Communications, etc.:

- **Joseph Belles-Town Council Place 4:** May 9th is Community Day at MCES. Wants more information on the 1032 Program. Can we get a list of businesses located in Trimax? We have a drainage problem at the Fire Department door. Concerned with Standard Operating Procedures regarding ride alongs.
- **Stan Simpson-Mayor:** Little Cove Road Extension applied for Raise Grant. Requested to get direct spending. Sending in Safer Roads Request Funding. Met with County Engineers and Commissioner on the sewer project and right-of-way availability. Water project is moving ahead. Met with Habitat for Humanity Team on Friday. The Gurley Historic Association Monument Park is basically completed. The Alabama League of Municipality Convention is in May. Manhole project needs approved by the State to complete.
