**Regular Meeting:**

The Town Council of Gurley, Alabama, met on December 6, 2022, at 7:00 p.m. in the Gurley Town Hall for a regular meeting.

Mayor Simpson called the regular meeting to order. Upon roll call, present were Richard Meyers, Robert Winn, Joseph Belles, Andy Whitten and Stan Simpson. Absent was Gary Boyett.

**Reading of Minutes:**

A motion was made by Meyers, seconded by Whitten, to dispense with the reading and approve as prepared, the Minutes of the Regular Meeting held on November 15, 2022. On voice vote, motion carried.

**d. Provisional Approval of Business License – Manic Organic:** A motion was made by Meyers, seconded by Belles to provisionally approve the business license for Manic Organic (dba My Brothers Coffee Co) upon the passing the inspections. - a. **Town Administrator:** Building Department report has 2 Commercial Projects and 8 Residential Project ongoing in the Town. Handbook is basically done and we will have it for approval at the Council Meeting on December 20<sup>th</sup>.

The Police Department will be having their firearm training tomorrow at the NASA Range.
- c. **Fire Department:** We've had 440 calls this year. January we will start working on the Centennial Celebration and the 6 projects we'll be working on. The paving around the Fire Hall has been better for the Fire Department.
