Regular Meeting:

The Town Council of Gurley, Alabama, met on February 6, 2024, at 7:00 p.m. in the Gurley Town Hall for a regular meeting.

- **Approve the Mayor to enter into a contract for the quote on Cemetery GPR Scanning:** A motion was made by Meyers, seconded by Belles to approve the Mayor to enter into a contract for the quote on Cemetery GPR Scanning in the amount of \$5,800.00. Motion carried on voice vote.
